A. Management Report, Jamie LaRue (pp.17-23)

As a note, Wellington Public Library just passed a policy to ban book banning. We may want the board to look into something like this and what it would mean. The Board would like more information from library regarding displays and reclassifications, the Board will discuss this in a future meeting. In light of recent legislation we are now conducting background checks on all library volunteers.

B. Financial / Treasurer Report, Michelle Foster (pp.24-28)

Sales tax collection is up 12.3% from 2021. The Budget Committee will be presenting the 2023 budget draft at the October board meeting.

C. Engagement Survey Presentation, Kim Owens

82% employee response. Overall employees are reporting a high level of satisfaction with the organization. Would like to see more FT positions. This will be an annual survey.

D. Branch Report, Amy Tonozzi, Rifle Branch Manager (pp.31-32)

Door count is finally starting to go up. Fully staffed as of July. Have 4 Spanish speakers on staff that have helped to reach out to that community. Offering more Spanish speaking programming. 500 people came to Hispanic Heritage Festival. Want to try some type of Lift-Up event for food for the homeless.

E. "Did You Know", Carolyn Tucker

Rifle was found in 1882 by Abram Maxfield someone found a rifle by a creek. Population has grown a little over 10,000 people now. Rifle, Silt, New Castle about 7 miles apart because steam engines had to have a water stop every 7 miles.

Colorado Paid Family and Medical Leave Insurance Act (FAMLI) Decision options and Staff Recommendation

Required Decisions of the Board: The Library Board must make a decision regarding participation in Colorado's new paid FAMLI program. The purpose of this memo is to inform the Library Board of Trustees about the FAMLI program decision options:

- Decline Participation in the program: The decision to opt out entirely requires a
 vote by the governing body and written notification (see Resolution 22-1 in
 packet(a)) to the FAMLI Division before January 1, 2023. Employees will still be
 allowed to participate in the program, but will submit their premiums on their
 own. The Library will have the option to participate in the program in future
 years.
- 2. <u>Decline Employer Participation only</u> and allow employees to participate through payroll deduction: The Library has the option to allow employee payroll deductions into the FAMLI program. The decision to decline employer participation requires a vote by the governing body and written notification (see Resolution 22-1 in packet(b)) to the FAMLI Division before January 1, 2023. The Library will have the option to fully participate in the program in future years.
- 3. <u>Participate</u> in FAMLI program: The decision to participate is automatic with the FAMLI Division unless the Library formally opts out by January 1, 2023. A Library Board vote in public session is recommended. No written notification is required to be sent to the FAMLI Division.

Staff Recommendation: It is the recommendation of staff that the Library "Decline Participation" in the FAMLI program at this time. By deciding to opt out, the Library can best assess the benefits that are the best fit for the organization, evaluate budgetary concerns, and wait for additional rulings that will assist the Library in making future decisions around the FAMLI program. Employees desiring to participate will still be allowed to participate and can submit their premiums on their own. The Library has the option to participate in the program in future years.

Since FAMLI plan benefits will not be available to participants until January 1 2024, work will commence immediately as we consider the best benefit package that would meet or exceed the terms and spirit of the FAMLI program. We will thoughtfully look at our current paid time off policies, our disability insurance policies, and other benefit options to put together the best package for our organization. We intend on having a proposal prepared for your review and approval prior to January 1, 2024.

Recitals

FAMLI will be funded by premiums paid by Colorado employers, employees, and, independent contractors that elect to participate in the in the program with premium collection commencing January 1, 2023, and benefits beginning January 1, 2024.

FAMLI provides that any "local government" "employer", as defined by §§ 8-13.3-503(14), 29-1-304.5(3)(b), C.R.S. and § 8-13.3-502(8), C.R.S., may register with the program by January 1, 2023, and a local government employer that fails to register by January 1, 2023, will be deemed a participate in the program.

FAMLI provides in § 8-13.3-522, C.R.S., that a local government employer may decline participation in the program upon a majority vote of its governing body, provided the governing body first holds a public hearing on the matter with prior written notice to employees summarizing the program and vote process and giving employees opportunity to submit comments.

FAMLI also provides that, to avoid being subject to premium collection commencing January 1, 2023, a local government employer must register with the program and provide notice of a decision to decline participation by January 1, 2023.

Any local government employee whose employer declines participation may elect to participate in the FAMLI program as an individual and, a local government employer declining participation may elect to help facilitate its employees' participation by collecting and remitting the employee premiums. The Board of Trustees of the Garfield County Public Library District ("District") held a public hearing at a public meeting herd November 3, 2022 at 2pm at Silt Branch Library, Silt, CO, and District employees were provided written notice of the public hearing and apportunity to comment on the District's participation in the program.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE DISTRICT AS FOLLOWS:

- 'The Board finds and determines that, with regard to the public hearing on the
 decision of whether to decline participation in FAMILI, notice was given and the
 hearing was conducted in accordance with FAMILI and the rules and regulations
 adopted by the Colorado Department of Labor and Employment
- The Board of Directors, acting for an on behalf of the District, kereby declines participation in the FAMLI program.
- 3. The District will not facilitate premium collection and remittance for employees that elect to participate in the FAMLI program.
- 4 District management shall implement this Resolution consistent with FAMLI and the rules and regulations adopted by the Colorado Department of Labor and Employment.
- 5. Provided the Board does not subsequently elect to participate in the FAMI I program, the District's declination is effective for eight years from the date of this Resolution, and the Board will determine whether to continue declining participation in the FAMI I program prior to expiration of the eight-year period.

The Buard of Trustees of the Garfield County Public Library District ("District") held a public hearing at a public meeting held November 3, 2022 at 2pm at Silt Branch Library, Silt, CO, and District employees were provided written notice of the public bearing and opportunity. to comment on the District's participation in the program.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE DISTRICT AS FOLLOWS:

- The Board finds and determines that, with regard to the public hearing on the 1. decision of whether to decline participation in FAMLI, notice was given and the hearing was conducted in accontance with VAMLI and the rules and regulations. adopted by the Culorado Department of Labor and Employment.
- 2. The Board of Directors, acting for an on behalf of the District, hereby declines. participation in the FAMLI program.
- 3. The District will facilitate premium collection and remittance for employees that elect to participate in the FAMLI program.
- 4. District management shall implement this Resolution consistent with FAMLI and the rules and regulations adopted by the Colorado Department of Labor and Employment.
- 5. Provided the Board does not subsequently elect to participate in the FAMLL. program, the District's declination is effective for eight years from the date of this Resolution, and the Board will determine whether to continue declining participation in the FAMLI program prior to expiration of the eight year period.

Management Report, November 2022

By Jamie LaRue, Executive Director

In district

I had the opportunity to participate in a couple of Interviews at Silt for our circulation coordinator position. We have begun to experiment with more "behavioral" interviews, in which we ask someone not just to describe how they would train someone in a procedure, but to demonstrate the skill. I appreciate Kim's willingness, and staff's flexibility and curiosity, to try some new things.

We have also been getting ready for district-wide **personnel evaluations**. Often, evaluations are done annually, at the employee's anniversary date. But there are some advantages to reviewing all staff within a shorter period. It not only clarifies the next budget year, but allows for greater consistency in evaluation standards across the district. Kim and colleagues have put in a lot of time simplifying and refocusing our forms.

Incidentally, I see that my own **six-month evaluation** is coming up. I look forward to discussing the process with the board.

I have attached a DRAFT **Goals for 2023** document. Based on various conversations within and without the district, this framework tries to whittle down our focus to a few big things. For evaluations, this is handy to align personal development goals with district needs. To be clear, we will continue with our existing collection and program activities, which are all going well. I believe the proposed goals are the big *initiatives* worth focusing on. I would appreciate any board feedback, particularly around the idea of adopting a more formal long range or strategic plan by fall of next year, perhaps at a board retreat.

In the community

As mentioned last month, many of Garfield County's historic associations face significant challenges. I had the chance to meet with Bill Knight, executive director of the **Glenwood Springs Museum**. The museum recently completed what sounds like a fascinating grant project: oral histories of Hispanic settlers and longtime Garfield county residents. We would be interested in debuting the video at our Glenwood Springs Branch Library, and cooperating on future exhibits and programs.

Bill also expressed interest in two other ideas: shared climate-controlled storage for irreplaceable historic artifacts and documents (many are now at great risk) and some assistance with the creation of "metadata" or cataloging records for museum holdings. Neither is currently reflected in our budget, but I hope to discuss further with other historic associations, and may have a proposal by the end of the year.

In the profession

CALLI training

On October 21, 2022, I delivered a day's worth of training with my colleague Sharon Morris (Principal Public Library Consultant for the Colorado State Library) for the Colorado Association of Libraries Leadership Institute (CALLI). The topic was communication, and covered everything from emergent leadership to coaching to crucial conversations. Participants also got the chance to practice group dynamics and evaluation exercises. We have two managers, Stacy Kline and Daniel Messer, participating in CALLI this year. The program does a good job of not only communicating various leadership skills, but in building a network of library colleagues across the state.

Community interviews

Since before I came to Garfield, I have been assisting several Colorado libraries in the conducting of community interviews, and hope to launch a similar process here. The State Library noticed the interest in community-centered planning, and is considering putting together a statewide training series on the topic, probably for early next year. While the full presentation is still under development, I will likely provide some overall training, with implementation discussion from Littleton, Pine River, and Montrose.

Arizona Library Association keynote

On October 27, 2022, I delivered the keynote for the Arizona Library Association conference in Prescott, Arizona. The topic was again "Transforming Libraries," about trying to make more systematic what we do every day: help our patrons, communities, and society to grow and learn.

Censorship

This issue is both local and professional.

First, I wanted to record some facts about the Japanese manga that have been challenged here.

- First, the items being challenges are and have always been cataloged and shelved as adult materials.
- Second, in Silt, the books are shelved about as far away from the children's collection as space permits.
- Third, the challenged books come with a pre-printed publisher tag on the cover, which states, "Parental Advisory: Explicit Content." (Note: not all manga titles are adult oriented.)
- Fourth, it has been alleged that someone found the books as part of Pride Month displays (on lower tables near the library entrance). If so, library staff didn't put them there. But we've also had, over the past few weeks, several cases of adult books being deliberately mis-shelved in children's areas, perhaps to precipitate controversy.

Second, as noted in this article (www.vice.com/en/article/y3p3yb/teens-are-fighting-back-against-lgbtq-book-bans), there have begun to be many instances of local youth pushing back at organized campaigns to shield them from materials they either aren't interested in, or are perfectly capable of understanding.

Violent threats against libraries

In the past several weeks, at least two public libraries in Colorado have been "swatted"--meaning that someone called in bomb threats, resulting in the deployment of SWAT teams. Both proved to be unjustified, and in fact there have been a high number of such events happening, mostly to schools, and apparently (according to an NPR news piece I listened to) tracked back to an Ethiopian IP address, although the exact source has not been verified. The following article gives a little more context. https://www.vice.com/en/article/g5vmp4/libraries-are-beefing-up-security-after-a-series-of-violent-threats.

Taken together, it's clear that libraries, like many public institutions, continue to be the targets of both mischief and misleading charges. Our best defense continues to be clarity of purpose, and consistency of policy and procedure.

Silt Branch November Report

The Silt library has been busy with a great Spring, Summer, and Fall full of family activities.

The Silt team now has two native Spanish speakers pursuing ways to support our Hispanic community through conferences, community connections, and programs such as Loteria.

We lost three team members over the summer; One to college, one to support services, and the other to life changes.

In two months, we've gained an excellent new page named Ashley and a specialist named Natasha. Our team has changed, but the unique talents and passion for serving this community are ever-increasing. Every team member actively seeks ways to improve our services through conferences, observing other libraries, and online resources.

We have a nice stream of teens and families coming in to do our weekly scavenger hunts in the library. On average, these passive educational programs bring 42 kids and teens into the branch. Our program attendance has stayed strong through our hard work marketing to the community each week.

We are strengthening our strong relationship with the schools through quite a bit of outreach inside the school. We are working closely with the Vice Principal to bring our complimentary resources to the families that need them most and the teachers. We will continue outreach in the school for book clubs and training the teachers on our resources. We have come into the school for teacher conferences and created about 20 library cards for the families walking through.

Faculty members were thrilled to see us there and asked us to come as often as possible to reach these kids.

We have, on average, eight programs a week that bring in all ages from our Hispanic and Anglo communities.

We are focusing on bringing in families through programming but working towards reaching our teens and seniors to stay in step with our promise to the voters in 6A.

We are starting a chess club, teen book club and will be in the high school starting a podcast with the teens. We created a program in partnership with the Colorado Workforce to help our community get the resources they need to find a job they enjoy and a nutrition class for low-income families and seniors. The nutrition classes were well attended. We are looking at all the ways to better serve our Hispanic community in every area of the library. We are very excited to see this shift in our customer service.

We have celebrated quite a few heritage months in an educational, fun, librarian way. This month we celebrate German, Polish, and Italian heritage in our displays and scavenger hunts, and kids get to learn about the food, culture, and lifestyles.

As an entire team, we have become a great support to the town in its events, doing more than 18 outreach events in partnership with the city and will continue to do so into the winter months. We are constantly improving the seating area in the branch, and patrons love it. We'll see many patrons come to sit in our little nooks.

Thank you for approving the budget so we can better serve our community. Staff is already making adjustments in preparation for the improvements ahead.

Financial / Treasurer Report, October 2022

Net sales tax collection year to date is up 13.1% from the same period in 2021.

The 2023 draft budget was posted to our website for public comment on October 10, 2022. A Notice of Budget was published in the Citizen Telegram on October 13, 2022.

According to the Garfield County Economic Update for Third Quarter 2022, produced by Colorado Mesa University Davis School of Business, the national inflation rate for the previous 12 months ending in August is 8.3%, while the Mountain CPI which includes Colorado inflation rate is 9.6%. Rates in food and shelter keep rising while slight reductions in energy occurred in August.

75% of the year has elapsed as of 9/30/22.

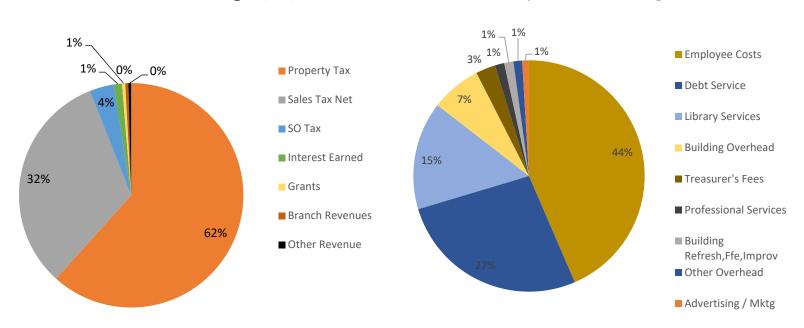
94.42% of budgeted revenue (\$9,196,298) has been received.

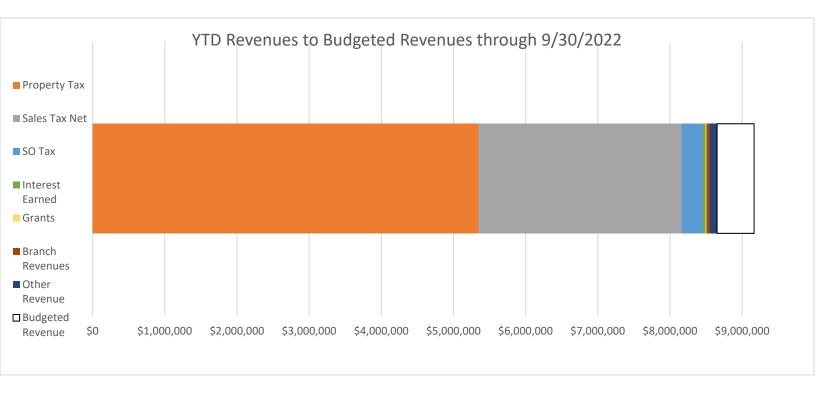
68.29% of budgeted expenditure (\$9,196,298) has been made.

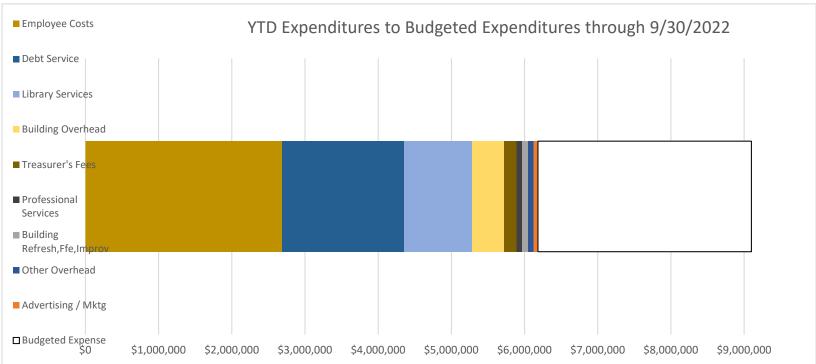

Citizen Oversight Committee 2022 Annual Report

Committee Purpose

The Citizens' Oversight Committee shall assist the Board of Trustees in fulfilling its oversight responsibilities related to income and expenditures resulting from the November 2019 passage of ballot measure 6A. Revenues generated from 6A are used for library purposes that may include restoring library hours; keeping library facilities well-maintained and in good repair; retaining qualified staff; providing books, technology and other library materials; and providing educational classes and events for children, teens, and adults.

Committee Meeting Narratives

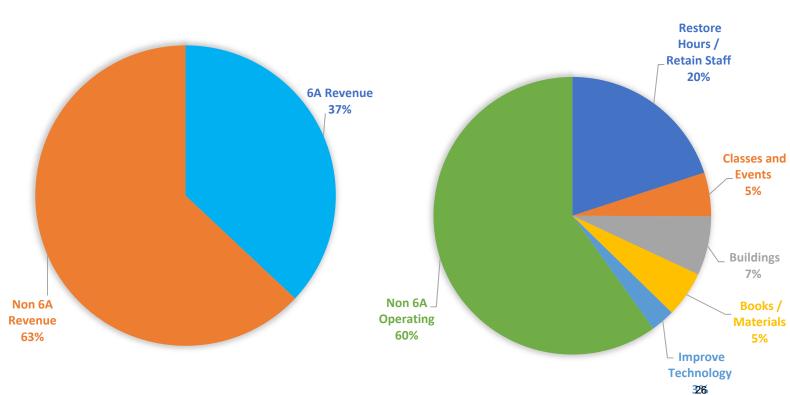
The Committee met in April and October 2022. We reviewed the Board approved committee charge and discussed how the committee was formed through the voter approved 2019 ballot measure 6A. We reviewed the ballot language and discussed each of the major categories of 6A spending commitments. We reviewed the District's 2022 6A budget and profit and loss statement for spending through March 31 and Sept 30, 2022, respectively, highlighting the major categories of spending with increases in staff development, events, library collections, buildings, and technology. We discussed the rising attendance at most of our classes and events for all age groups, and demographics. Expansion of open-door hours to seven days a week, and many new successes in 2022 that we will be expanding on in 2023.

The following charts reflect year-to-date 2022 revenues and spending through 9/30/2022, broken out by 6A and non-6A categories.

The Committee's next meeting is scheduled for April 20, 2023.

Technical Service Update October 2022

Jenn Cook, Technical Service Director

The last couple of months have stretched the technical services department as all three team members have needed to back each other up through some unavoidable absences. We have managed to do really well to stay on top of ordering, record management, material processing, and other general support for the branches during this interval. Acquisitions are beginning to ramp up towards finishing out the 2022 budget purchases and preparing for the fiscal year-end close process in Sierra.

Our digital collection is growing!

Because eAudiobooks have consistently remained over 50% of our total Hoopla checkouts, and eBooks make up another 30%, we will soon be providing patrons with additional Hoopla borrows that can be used at any time on available "flex" eBooks and eAudiobooks that are purchased directly by the District exclusively for our cardholders. These titles allow patrons to borrow new, popular, and high-demand eBooks and eAudiobooks above the ten Hoopla "instant" borrows that patrons can currently download each month with their library card. Unlike "instant" borrow limits that expire at the end of every month and then start over for the next month, "flex" borrows have a separate rolling limit, so as soon as one title is returned, the limit instantly resets. Both Hoopla "instant" and "flex" titles are accessible through the same Hoopla Digital app patrons are already using and enjoying.

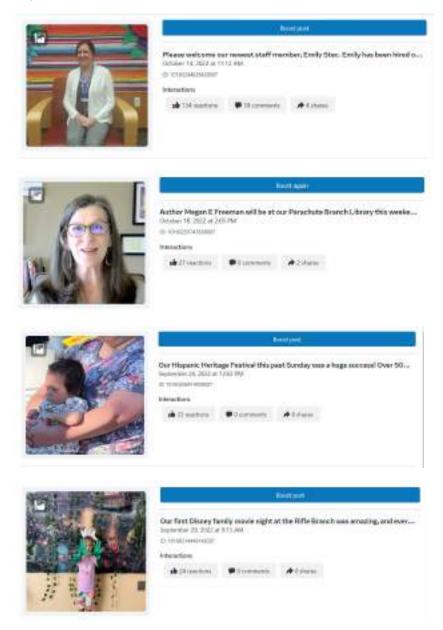

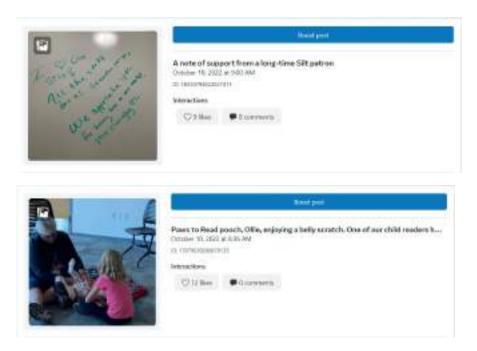
Top 5 Facebook Posts





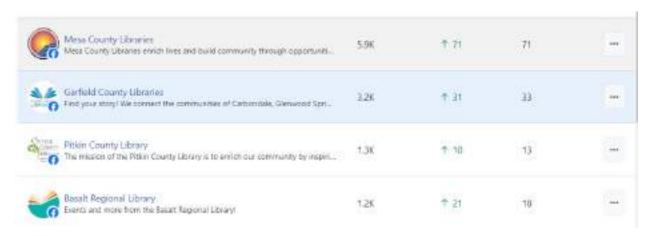
Top 5 Instagram Posts

BOOK REVIEW

'Tarzan, Conqueror of Mars'

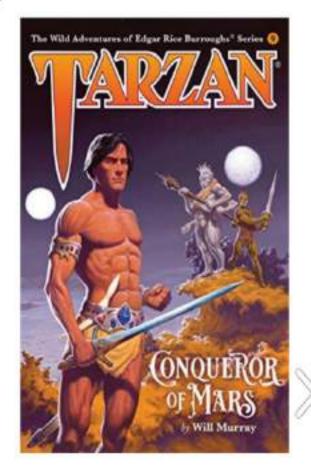
I learned to read from comic books. At first, I mostly read DC Comics, mainly Superman. I was the only 6-year-old on my block who could spell "invulnerable." Later, I got into Marvel comics. Then, I worked my way into classic pulp fiction. Among the most thrilling of these titles were works by Edgar Rice Burroughs, often referred to by fans as ERB.

Perhaps his greatest and bestknown heroes were Tarzan of the Apes and John Carter of Barsoom. Both series began publication in 1912. ERB wrote 26 Tarzan books, and 11 featuring John Carter.

Unfortunately, ERB never got around to writing a book in which two of his greatest heroes encountered each other. But a modern writer, Will Murray, has done it for him.

Published in 2022, available through the Garfield County Libraries' Hoopla service as an audiobook, "Tarzan, Conqueror of Mars" can make the highway miles fly!

The premise: while recapturing an evil sorcerer, Tarzan finds himself cursed with a spell that easts his spirit into the African



night's sky. When he awakens, naked, without his father's hunting knife and the locket featuring the images of the human parents he never knew, he doesn't know whether he's alive or dead.

In fact, he's on Mars, which the natives call Barsoom. He discovers that his earthborn muscles give him superhuman strength, such that he can bound over the ground like the Hulk. Soon, he encounters the perils of a bizarre floating creature whose tentacles inject their prey with poisonous gasses, after which a most gruesome fate ensues. Then he meets the so-called White Apes of Barsoom. Then he captures the heart of what may be the last member of an ancient Barsoomian race, a woman who has lived 10,000 years. There are the six-limbed and betusked green men. There are red men.

And so on. Eventually, Tarzan of the Apes meets up with the Warlord of Barsoom himself, John Carter of Virginia. Murray does a marvelous job of capturing the feel of ERB. Not only is the language very like the originals, Murray nails the enthralling episodic nature of the plotting. Wild animals! The clash of armies! The mixed savagery and nobility of Tarzan himself; the more civilized and calculating John Carter.

In a Marvel comic, whenever two heroes or antiheroes meet, they have to fight each other before they get around to having anything so mundane as a conversation. And so it is here. Who wins?

The reader.

For anyone who never quite outgrew the excitement of brisk storytelling that features larger than life heroes, "Tarzan, Conqueror of Mars" is eagerly recommended.

State and local libraries assist historians

The Carboncide Historical Society was recently invited, along with Gartield County's other cultural heritage Institutions, to attend a sension busined by Gartield County Libraries District (GCPLD) Executive Director James Laffase. The suminar took place on Sept. 26 at the Climwood Springs Library, and Sensed on the digitization of historic photos, documents and nanospapers. Digitization involves the currencion of text, just need to computer.

The sensiner was led by Amy Hirchner and Leigh Jenemias, both from the Colorado State Library Digital Collections Department. The morning session introduced the Colorado Historic Newspaper Collection (CHDC) and the Digital Public Library of America. These theo researces puncide valuable information from Colorado's past for anatom, so well as professional macanchem.

A service of the Colonulo State Library, the CHNC features more than 2.5 million scarnfishle pages from over 620 newspapers published in Colonulo from 1850 through 2021. The collection includes 1,574 issues of the Avalanche-Echo, published in Glenwood Springs between 1890 and 1924. Those issues were digitized from microfilm held by History Colonulo and originals held by the Glenwood Springs Hestorical Society.

The morning session concluded with a panel discussion by representatives of local historical institutions, including Carbondale, Glenwood Springs. New Castle, Rifle and Grand Valley, which revealed ongoing digitization projects being undertaken to preserve historical archives and make them publicly accessible.

Carbondale Historical Society is regrently in the process of digitating hundreds of documents in their archives. The process involves scanning, creating PDFs. ascribing a file number and uploading documents to Gongle Drive. Escartnally, a master list will be created which will be searchable by names, dates and topics. These documents will then be put on a hosting platform and much available to the public for generological and historical research.

After a banch break, participants returned for the afternoon session to know about tools and resources provided by state and local illustries to assist them in digitizing their collections. The libraries will bun Digitol Creation Kits to institutions and individuals, and will even help with grant witing to find funding for the digitization process.

In addition to providing a valuable resource for historical was used, digitarities protects the information held by historical institutions. Most of the massume in our area don't have the proper facilities for storage of physical documents, photos and resopapers. To do this properly requires strict temperature and humility control. Digitarities of these previous historic collections assumes that in the case of fire, flood or other disasters, the information will not be lost.

Upon hearing about the storage diference shared by these various institutions, GCPLD Director Laikin expressed a desire to belp flad a solution for preserving these valuable collections in their physical form. Laikine invited the historical societies to continue discussions with GCPLD to discover the best way to purtner on collections storage.

The Carbandale Historical Society has for some time been concerned about the storage of their historical archives. These archives contain original photos and documents belonging to Carbondale's early pioneer families, including William Dialed, Wallace Dellegue, Hantie and Osear Holland and the Thompsons.

These archives currently scaide in the Pioneer Log Cobin Museum et 499 Wennt Blvd. The cobin, built in 1887 by homesteaders, has no air-

conditioning or lise protection, putting the archives in jeopardy of deterioration or outright destruction.

In 2022 the Carbondale Historical Society received a great from the town of Carbondale to assist in the digitization and preservation of their collections. But more funding is peeded to assure the entirety of the archives will be protected and accessible to future generations. The organization is hopeful that through private donations and grants, and with the assistance of the state and county library systems, the history of Carbondale will never be lost.

Book ban efforts in Colorado see little success amid national uptick

One town banned book bans. Some rally against censorship.

While efforts to ban books in certain genres have increased across the country as of late, Colorado has also seen a few book-ban efforts - but not nearly as many as the rest of the U.S.

Nicolle Davies, assistant commissioner of the Colorado State Library, noted that Colorado is a localcontrol state, so the state library itself doesn't directly deal with book bans or challenges. But local libraries are supposed to report to the state any challenges to material the libraries offer, and the state tracks the challenges. In 2021, the state had 20 challenges reported, the majority of which related to LGBTQ communities. This number was double the amount of challenges reported in 2020.

Jamie LaRue currently serves as executive director of Garfield County Libraries, but spent three years at the helm of the American Library Association's Office for Intellectual Freedom and 24 years with Douglas County Libraries. In his time at Douglas County he said he got about 250 challenges, which he described as "an attempt to either remove or restrict access to some library resource, so it could be a book, could be a movie, could be a periodical, it could be music CD, could be an exhibit could be a speaker, all kinds of stuff."

LaRue said in his experience, most challenges come from parents of children age 4 to 6 or parents of children age 14 to 16. This is because these are stages in a kid's life when they are transitioning from infancy to childhood or from childhood to adulthood, he said.

"I began to notice that as I looked at the top 10 challenges each year, they fell into two categories of their own: They were either about the LGBTQ (community) or about people of color," LaRue said. "That means, who is challenging most of these books? The answer is kind of a majority — so basically straight white people."

LaRue attributed the recent national uptick in book challenges to 2022 being an election year. He said the challenges are "coordinated campaigns" by people with similar opinions on exposing teenagers to information on gender, race and sexuality, making threats against politicians and other officials. There have even been attempts to file criminal charges against librarians in some states, including Iowa, Idaho and Oklahoma for allowing access to books that are "obscene or harmful to minors," LaRue said.

Davies agreed the national uptick is "indicative of what's going on in our country" when it comes to divisiveness.

"I feel like we're just more divided than we've ever been, and that's kind of playing out in all sorts of different ways," Davies said. "In Colorado we're not seeing the same volume, so I don't know how much of the political landscape of the state plays into that."

While Davies said she doesn't know exactly why Colorado is not seeing the same volumes of challenges as other states are, she'd like to think Colorado is further along in accepting new ideas and ways of thinking.

To Davies, libraries are an opportunity for someone to find accurate and important information to formulate their own opinions. People who work at libraries are qualified professionals who have no agenda other than helping their patrons find the publicly available information and ideas they seek, she said.

"The two things you really need in a democratic society are free press and public libraries," Davies said.
"People need to be able to formulate their own ideas and be able to get good quality information that's accurate, and that's what happens at a public library. When you start to play around with the profile of a collection, you risk not providing an accurate and balanced perspective."

LaRue also cited an ALA poll conducted earlier this year that showed 71% of voters oppose efforts to ban books. The poll also found that a majority of parents support an individual parent's right to set rules and standards for their own children, but they don't have a right to dictate what materials are available to other children.

Colorado book ban efforts

There have been three key book ban-related events in Colorado, LaRue said: an attempted book ban in Gunnison, a ban on book bans in Wellington, and a school board president in Colorado Springs asking parents to bring "objectionable materials" to the school's attention.

Earlier this year in Gunnison, a woman challenged a book called "Gender Queer: A Memoir," seeking its removal from the Gunnison library collection, the Gunnison Times reported. The title is a comic bookstyle memoir describing the author's life growing up as nonbinary and asexual — it has been the target of many groups looking to censor the shelves of school and public libraries.

The Times reported that a library board meeting saw a turnout of at least 75 people, the majority of whom opposed removing the book from the library and came to show support for the LGBTQ community. The library board did not make a decision at that meeting after hearing public comment from more than 30 people.

The library's director reached out to the person who made the challenge, informing them the library would keep the book on its shelves.

In Wellington, a small town north of Fort Collins, the town's Board of Trustees also oversees the operations of the library. Wellington Mayor Calar Chaussee said a citizen initiative sought to ban or censor a list of books relating to gender and sexuality, but he said even as a conservative he doesn't think any entity should ban books. He said a majority of the books of concern offered a perspective different from a conservative Christian lifestyle.

"We should never be banning books, because if you start banning books and words then you're going to start banning ideas," Chaussee said. "If we do that, I mean, we're all lost, right?"

At Wellington's library, children who are 11 or younger cannot check out a book without adult supervision, and kids between 11 and 17 need parent consent to register for a library card. This means parents of minors are likely aware of what their kids are reading from the library.

The initiative trying to ban certain materials started to take up a lot of town staff time as well as trustee meetings with public comment. It led to a Board of Trustees member proposing a resolution that would effectively ban future book-ban efforts in the town, and the board passed it. Chaussee said it's even led to more citizens getting involved in the town's processes.

Ideally, Chaussee said he'd like to see other entities follow in Wellington's footsteps. He said especially in America, a "country where we want to promote freedom of speech and freedom of religion," starting to ban books becomes "a slippery slope."

In a video posted to the website of the Culture Impact Team, which aims to educate on issues of concern to the Church for All Nations, Tom LaValley, school board president at Academy District 20 in Colorado Springs, boasted about the district's commitment to academic excellence. He then said he believes in parental rights in education and encouraged parents to "in the words of Ronald Regan, 'trust but verify' what your children are being taught."

LaValley said he believes parents have every right to see every handout and video and to know "all the details" of what children are being taught in schools and that they need to hold teachers and the district accountable.

"Stroll through the school library. If you see objectionable material, go to the teacher or librarian, or better yet take several others with you who are like-minded," LaValley said. "If you don't get a satisfactory answer, then go to the principal, superintendent, or bring it to our attention on the Board of Education. Please partner with us. We need your eyes and ears in the classrooms. We want our classes delivering academic excellence, not woke agendas. Our job is to challenge kids to think, not tell them what to think."

Davies said it's important to note that school libraries operate differently than public libraries, so the process for challenging materials is different as well. She said there's an old adage about public libraries that says "if you have a great collection, you should have something to offend everyone," and that isn't the case for school libraries.

Pride Month challenges

Representatives from the library systems in El Paso and Mesa County both said they've seen material challenges coming through, but neither has removed any items from their collections. Most public libraries have a process for challenging a material or resource, and depending on whether a library is run by a district or a local government, the process for challenging something might differ. Denver Public Schools also hasn't had any recent attempts to ban materials.

In his current role, LaRue said he's seen four book challenges since he started in Garfield County in May. He said the challenges all came about when the library had a pride display during Pride Month.

LaRue said the real job of a library is to reflect cultural change. While the vast majority of library collections represent the status quo, LaRue said the small percentage of material expressing new ideas and methods of thinking are what the majority is afraid of.

"Libraries are mirrors. We hold a mirror to our culture," LaRue said. "We're not writing these books. We buy them from mainstream publishers. We buy them because people ask for them. We buy them because people are talking about them.

New Castle hosted on Friday September 23 and Silt hosted on Saturday September 24. The Glenwood and Carbondale libraries hosted Colorado author Jane Parnell on Tuesday September 27 and Wednesday September 28 featuring her book, Off Trail: Finding My Way Home in the Colorado Rockies.

November Facilities Board Report

The Facilities Department had a successful month in October by continuing ongoing projects and completing work requests. The following are worthy mentions that were completed within the last 30 days.

Boiler Maintenance at Rifle Library

The boilers at the Rifle Branch Library received some maintenance due to error codes that prevented them from functioning. The Facilities Manager worked with the contracted HVAC vendor to inspect and repair the issue. Boiler 1 was brought back to operational mode. Boiler 2 is temporarily offline due to it needing a new "Low Water Cut Our Safety Relay." The part is on order and will be installed as soon as it's been received.

Admin Office Space Project (Update)

The Facilities Manager has received the following updates from the Project Management team.

- VAVs are critical path at this point we are working through contracting with Trane but it is taking longer than expected due to job market.
- Framing is complete, electrical and mechanical rough in will be complete in next two weeks.
- Fire suppression and alarm will start beginning of November releasing rough in inspection and insulation to follow.
- Frames are arriving soon, once set we can finalize door slabs and hardware and get installed.
- VAVs will be installed when they arrive all other work is proceeding around them.



Here's a look at some of the area currently. There will be weekly work updates as the project continues.

District Power Washing & Roof Drain Cleaning

The Facilities Technician is making his way throughout the library locations power washing the exterior patio areas, clearing out all debris. In addition to this the roof drains are being cleaned of all debris as well ensuring that there is clear path for water flow. This takes place in the Spring and Fall.

Preventative Maintenance for District Sliding Doors

The library's contracted door company has made it's round of preventative maintenance on all sliding doors in the district. Areas such as belts, electronic relays and other mechanical parts were all inspected and adjusted. New Castle was the only location that was found to need a new replacement part. The interior bottom sliding track is nearing the end of its life and a new one was placed on order and will be installed as soon as it's been received.

Public Restrooms Reconfigure at Parachute Library

The Parachute library branch has reinitiated its original public restroom design space. For quite some time a temporary door was installed on the men's and women's restroom entrance, offering one to the public as a unisex and the other for staff. That set up is no longer needed and the Facilities Technician proceeded to oversee this project by removing both doors at the entrances and patching and painting the walls.

Updating 2023 Facilities Contracts

The Facilities Manager is currently working on organizing and corresponding with all vendors for the Facilities 2023 Contracts. The current vendors focus on work such as custodial, snow removal, HVAC preventative maintenance, carpet cleaning, window cleaning etc. The Facilities Department is grateful to have professional local companies to work alongside of in order to help keep the buildings in excellent condition for the community.
